Disability Rights Oregon's Crime Survivor Project (CSP) provides services to people with disabilities who have experienced crime—including sexual assault, intimate partner violence, and abuse—even if the crime has not been reported.

YOU HAVE THESE RIGHTS

- » To be treated with dignity and respect.
- » To be told ahead of time about court proceedings in your case.
- » To attend court proceedings in your case.
- » To know what punishment the defendant receives.
- » To be protected from the defendant.
- » To not to speak to the defendant or defendant's attorney before trial.
- » To not to give the defendant any documents or other information before trial.
- » To receive restitution from the defendant.
- » To speak to the district attorney about plea negotiations, in some cases.
- » To have a support person with you throughout the criminal justice process.



EPPDAPA RESTRAINING ORDER

EPPDAPA stands for Elderly Persons and Persons with Disabilities Abuse Prevention Act.

An EPPDAPA restraining order is a court order that requires someone to stay away from you and not have contact with you. It may be needed for your protection when someone is harming you.

What do you need to show to get an EPPDAPA restraining order?

- » You are a person with a disability
- » You have been abused within the past 180 days
- » You are in immediate and present danger of more abuse

There are other protective orders that may better apply to your situation:

- » Family Abuse Prevention Act (FAPA) Restraining Order
- » Stalking Protective Order (SPO)
- » Sexual Abuse Protective Order (SAPO)
- » Emergency Protective Order (EPIO)
